

### **EROSION AND SEDIMENT**

The Erosion and Sedimentation Control Program continues to be a major priority in 1982. The Bureau of Soil and Water Conservation has assumed responsibility throughout the State for implementing the Erosion and Sedimentation Program. The Bureau conducts numerous training sessions for Conservation District inspectors. New guidelines and revised methods of achieving compliance at earthmoving sites are introduced at the training sessions.

### PILOT WATER PROJECT


A "pilot water project" in the New Stanton area of Westmoreland County was initiated in the fall of 1980 by the Westmoreland Conservation District. Financial assistance was provided by the Department of Environmental Resources, Bureau of Resource Programming.

The purpose of the project was to inventory water usage in commercial, industrial, and residential sectors of New Stanton borough.

A majority of the motels have installed low-flow showerheads resulting in a substantial reduction in water usage. Water reduction saves money and consequently saves the money and the energy consumed to heat the water. (60% of the water used in bathing is heated.)

Seventeen residences were incorporated into the project utilizing water saving devices recommended by the Conservation District. The termination of the project disclosed an average savings in water use of 1,100 gallons of water per household, per month.

The Conservation District is implementing county-wide participation in the water savings project. Save water, Save energy, Save money!

The Westmoreland Conservation District has been coordinating "The Early Warning Flash Flood Program" since its inception in 1972. Among some of the improvements to have been incorporated into the system are: improved communications with emergency facilities, annual reviews conducted with the rainfall observers and a constant updating of reporting procedures. Westmoreland County recently entered into an agreement with the National Weather Service regarding installation of radio reporting rain gauge stations. By recording and transmitting information regarding substantial rainfall in significant headwater regions it is anticipated that the radio rain gauges will enhance the

### RURAL ABANDONED MINE PROGRAM (R.A.M.P.)


Provides long-term technical and financial assistance to land-users to reclaim, conserve and develop certain abandoned coal mined lands in rural areas. Funding is derived from taxation on coal currently being mined. Two projects have been completed in Westmoreland County at a total cost of \$60,000. Five other projects in Westmoreland County are planned and designed, estimated cost of \$520,000 if funding becomes available. Eligible landowners may apply for assistance with the Soil Conservation Service.

# RESOURCE CONSERVATION AND DEVELOPMENT PROGRAM (R C & D)

Penn's Corner Resource Development and Conservation Area provides financial and technical assistance to local sponsors in carrying our eligible R C & D measures having community benefits. They are: critical area treatment, public water based recreation, land drainage, and agriculture-related pollutant control. Projects completed and in progress in all Westmoreland County Parks and several borough parks. \$28,000 in construction cost provided in 1981 throughout the county.

### **OUTSTANDING COOPERATOR**

Honored in 1981 as the "Outstanding Farm Cooperator" in Westmoreland County was James Schenck. Mr. Schenck owns and operates Hays' Fancy Farm producing beef and grain. The farm is comprised of 625 acres and located in East Huntingdon Township near Scottdale. Implementation of conservation techniques has consequently resulted in a more functional farm and enhanced the overall asthetics of the property. The Westmoreland Conservation District commends Hays' Fancy Farms for the progressive applications of conservation practices.

At a time when there is a growing disregard for environmental problems, their economic consequences are becoming more apparent, according to Lester R. Brown in his new book. BUILDING A SUSTAINABLE SOCIETY" published by W.W. Norton. "Perhaps the most serious single threat humanity now faces is the widespread loss of topsoil," says Brown, President of Worldwatch nstitute in Washington, D.C. "Although world food output has more than doubled since 1950 that impressive increase has entailed land abuse so severe that at leasr one-fifth, and as much as one-third of the world's cropland is losing topsoil at a rate that is undermining its long-term productivity. Civilization cannot survive this continuing loss of topsoil."

Brown notes, "If not arrested, this loss of soil could cause the food problems to unfold during the eighties as the energy problem did during the seventies. Just as the world has come to depend heavily on the Middle East for oil, so it now depends

on North America for grain. And just as Middle Eastern oil is being depleted so too are North American soils. Recently released data show 34% of U.S. cropland now losing soil at a rate that is lowering its long-term productivity. At the existing intensity of cultivation, every ton of American grain exported means the loss of several tons of topsoil.
